EMERGENCY RESOLUTION RESCINDING RESOLUTION 25-07

The Legislative Council of the Village of Mechanicsburg, in Champaign County, Ohio met in regular session at the Village Services Building, located at 18 N. Main St. in Mechanicsburg Ohio on the 17<sup>th</sup> day of November, 2025, at the regular meeting with the following members present: Chip Wibright, Charles Hickey, Chuck Foss, Lori Tibbals, Billy Cobbs, and Scott Wilson.

WHEREAS, the Council of the Village of Mechanicsburg previously passed Emergency Resolution 25-07, and

WHEREAS, through passage of said Resolution 15-07, the Council of the Village of Mechanicsburg intended to provide temporary relief to the Mechanicsburg taxpayers, and

WHEREAS, the Council of the Village of Mechanicsburg has been advised that the Ohio Legislature recently passed a measure which, regardless of the Mechanicsburg Council's intent, would nonetheless result in the collection of said taxes and potential diversion of those tax funds to an entity other than the Village of Mechanicsburg , and

WHEREAS, such a diversion of Village funds would be a detriment to the taxpayers of the Village of Mechanicsburg and would nullify the intent of the afore-mentioned Emergency Resolution 25-07.

THEREFORE, BE IT RESOLVED that the Legislative Council of the Village of Mechanicsburg, hereby Rescinds EMERGENCY RESOLUTION # 25-07.

**DESIGNATION OF EMERGENCY ACTION:** This Resolution is considered on an emergency basis, for the public benefit.

**Vote Designating Emergency (>=3/4) :**


Having received the required three-fourths majority, this vote is designated to be an Emergency on this 17<sup>th</sup> day of November 2025.
